Welcome to NatureWorksPark. The Blair County Conservation District hopes you have an enjoyable experience at the Park. As a Permit Holder, you agree to the following Rules and Regulations, which were established to help ensure the safety and pleasure of you and your group as well as other visitors to the Park. Please be considerate of those using the Park around you and who will use the facilities after you. Violation of these Rules and Regulations may result in the immediate loss of the Permit without refund and removal from NatureWorksPark.

RULES AND REGULATIONS

1. Reservations accepted Monday to Friday between 8 am and 4 pm by stopping at the Blair County Conservation District Office at 1407 Blair Street, Hollidaysburg, PA, or calling 814-696-0877 Ext. 5 followed by full payment. Cash, check or money order made payable to the Blair County Conservation District will be accepted.
2. NatureWorksPark is open dawn to dusk. All pavilion reservations and occupants will also be dawn to dusk.
3. There is no water or electricity at the site. Portable restroom facility is provided.
4. Reservations are in full day increments only and the reservation price is per pavilion.
5. Reservation is for the pavilion not for the entire site. Reservation will be posted at the pavilion.
6. Reservations must be paid at least three (3) days in advance of the desired reservation.
7. Security Deposit of \$100 is required and must be paid at least three (3) days in advance of desired reservation. Cash or a separate check or money order payable to the Blair County Conservation District will be accepted. Security Deposit will be relinquished if damage occurs or significant cleaning is required post reservation.
8. A \$35 fee will be charged for any check returned by the bank for insufficient funds.
9. Cancellation is only permitted if done at least seven (7) days in advance of reservation. Full refund will be made for cancellations done at least seven (7) days in advance of reservation.
10. Use of nails, staple guns, thumbtacks, putty and adhesives are prohibited. Use of string or twine to hang decorations is permissible.
11. Please use garbage and recycling receptacles.
12. Please clean grill and dispose of ash in the appropriate receptacles.
13. Only use the grills provided at the site. Additional grills (charcoal or gas) and open fires are not permitted on site.
14. Use of electric generators is prohibited.
15. Motor vehicles are not permitted to drive beyond designated parking areas.
16. Pets are permitted as long as they are attended to and remain on a leash not exceeding six (6) feet in length AT ALL TIMES.
17. Alcohol, smoking, illegal and indecent conduct prohibited.
18. Firearms, air guns, archery equipment, fireworks and explosives are prohibited.
19. Solicitation for any purpose including the posting of signs is prohibited. The distribution, sales, servicing or rental of any supplies, equipment, material and/or commodity is prohibited.
20. Any and all Borough of Hollidaysburg ordinances must be followed.
21. In addition to payment of Permit Fee, (1) organized instruction, exhibition, competition, demonstration or special events open to the general public ; or (2) use of bounce houses, trampolines or similar type items, require prior written approval from the Conservation District including meeting the Conservation District's insurance requirements prior to the event.

By signing this Permit, the Permit Holder hereby agrees to be legally bound by these rules and regulations. In addition, Permit Holder shall indemnify and hold harmless NatureWorksPark and Blair County Conservation District from and against any and all liability regarding Permit Holder's use of the facility associated with this Permit.
